## School Tax Credit-Extracurricular Activities

### What is the tax credit?

A tax credit is a dollar-for-dollar reduction in the taxes you owe the State of Arizona. Participating in this tax credit program will allow you to precisely reduce the amount you owe the State or increase your tax refund from the State. When filing your taxes for the State of Arizona, the amount you designate to your school will be the amount you may claim as a State tax credit. This payment is eligible for Arizona state income tax credit as allowed by A.R.S. §43-1089.01 and also may be eligible for a Federal income tax benefit.

### KEEP YOUR TAX MONEY LOCAL! Direct your tax dollars to local students...

Single individuals may contribute up to \$200 ( \$400 for married filing jointly) to Topock Elementary School and receive a tax credit of equal value when you file your tax return. By doing this now, you will reduce the amount of taxes you have to pay by April 15th or increase your refund by the same amount. And by giving it to Topock Elementary School, the money stays in our community instead of going to Phoenix. It's a win-win for all!

Deadline to participate for Tax Year 2017 is April 15, 2018
